What will we do during our time together?

The funeral and cremation planning process will take time and involve many decisions. In order to accomplish the necessary procedures, you can expect the following conversations to take place:

- ❖ Discuss any specific needs or concerns regarding the cremation process.

- ❖ Collect the necessary information for completion of all required documentation.
- ❖ Collect and confirm funeral notice information
- ❖ Prepare and present a Statement of Goods and Services.
- ❖ Provide options relative to payment of services.
- ❖ Complete all necessary authorizations, and present you with a copy of all signed documents, as well as other pertinent paperwork or forms.

Itemization of Goods and Services

Professional Services

- I. Services of Funeral Director and Staff \$1,850.00
This is a basic fee that we charge every family for our professional expertise in assisting them with their preferences. It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charge includes, but is not limited to, consultation with the family, administrative and clerical services, preparation of the death certificate for certification by the attending physician or coroner, completion of necessary permits, required filings with appropriate agencies, consultation with clergy, cemetery, crematory or common carrier, assistance with insurance papers, planning all services, preparation and placement of newspaper obituary notices and direction/supervision of services requested by the family. There is a charge for each service requested or required. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our value package options, such as direct cremation or immediate burial.) Deaths outside of Sonoma County may require additional fees.
- II. Embalming \$525.00
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Forwarding of remains may require an alternative shipping container or casket, transportation costs (airfare), or consulate and/or shipping/handling fees, which are not included in this cost. This charge does not include any merchandise, additional preparation of remains other than what is noted above, visitation or viewing, or any funeral ceremonies. For these and other options, please refer to the itemized sections of this General Price List.

Receiving of Remains from another Funeral Home \$2,450.00

This charge includes a reduced fee of our Services of Funeral Director and Staff, Transportation from San Francisco International Airport, Transportation to Cemetery (Hearse.) This charge does not include any merchandise, additional preparation of remains, visitation or viewing, or funeral/cemetery graveside services. For these and other options, please refer to the itemized sections of this General Price List.

Immediate Burial (without formal ceremony) \$2,250.00

This fee includes a reduced fee of our Services of Funeral Director and Staff, Transfer to the Funeral Home, Refrigeration, Transportation to Cemetery (van). This charge does not include any merchandise, additional preparation of remains, use of facilities for viewing/visitation or funeral ceremonies. For these and other options, please refer to the itemized sections of this General Price List.

Direct Cremation (without ceremony) \$1,850.00

This charge includes a reduced fee of our Services of Funeral Director and Staff, Transfer to the Funeral Home, Refrigeration, Cremation by Daniels Chapel of the Roses Funeral Home & Crematory. This charge does not include any merchandise, cremation container/cremation casket, urn, additional preparation of remains, viewing/visitation or funeral ceremonies. For these and other options, please refer to the itemized sections of this General Price List.

If you want to arrange for a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard and fiberboard containers.
